# Examination och betyg

Kursen bedöms med betygen A, B, C, D, E, FX eller F.

The grades A, B, C, D and E are all passing grades. For courses with more than one element of examination, students are given a final grade based on an overall assessment of all the elements included in the course. The final grade of the course is issued only when all elements of examination have been passed.

The examination is based on instruction and course literature.

The course is examined through written and oral assignments.

- Written group assignment - 2 credits, Grading Pass/Fail In groups assigned at the beginning of the course students will elaborate a project for a communication intervention to address a crisis situation.

- Group presentation - 2 credits, Grading Pass/Fail In the groups assigned at the beginning of the course students will present the group project orally to the class.

- Individual written assignment - 3.5 credits, Grading A-F The individual written assignment consists on an argumentative text in which the student will discuss a chosen topic from the perspectives of the theories and concepts covered in the course.

Grading criteria individual written assignment:

A - The student shows an excellent level of theoretical understanding, ability to think independently, apply theories to analyse social phenomena, and the analytical skills necessary to question and problematise the theories and concepts covered in the course. The student must also be able to articulate arguments in the adequate academic style and in a clear and formally correct manner.

B - The student shows a very good level of theoretical understanding, ability to think independently, and apply theories to analyse social phenomena. The student must also be able to

articulate arguments in the adequate academic style and in a clear and formally correct manner.

C - The student shows a good level of theoretical understanding, ability to think independently, and apply theories to analyse social phenomena. The student must also be able to articulate arguments in the adequate academic style and in a clear and formally correct.

D - The student shows an acceptable level of theoretical understanding and ability to think independently and apply theories to analyse social phenomena. There are inadequacies in style and formal mistakes.

E - The student shows limited theoretical understanding and ability to think independently and apply theories to analyse social phenomena. There are inadequacies in style and formal mistakes.

F (Fail) - The student is not able to show the ability to think independently and apply theories to analyse social phenomena. Form and style are inadequate to an academic text.

Fx (Fail) - The assignment has not been submitted

Students are guaranteed a minimum of three attempts to pass an examination, including the regular attempt.

If a student has failed the same examination three times, the student is entitled to request that the next examination be assessed and graded by a new examiner. The decision to accept or reject such a request is made by the vice dean of education. A student may not make a second attempt at any examination already passed in order to receive a higher grade.

In case a course is terminated or significantly altered, examination according to the earlier syllabus shall be offered on at least two occasions in the course of one year after the termination/alteration.
