### Intended Learning Outcomes (ILO)

On completion of the course, the student should be able to:

Knowledge and understanding

- demonstrate knowledge of central concepts, theories, and methods used within social science sustainability research
- present an overview of current research, related to development work and strategies for sustainability within social sciences

Skills and abilities

- discuss how social science and interdisciplinary research can contribute to sustainable development in different situations
- compare different sustainability strategies within social science and interdisciplinary research and their implications for sustainable development in different situations

Judgement and approach

- assess social and ethical considerations in research and development work within social science and interdisciplinary sustainability research
- critically reflect over and discuss the roles of social science and researchers and what responsibilities they have towards their disciplines, individuals, and society

### Type of instruction

The teaching consists of lectures, seminars and exercises performed individually and in groups.

A learning management system is used.

Students who have been admitted to and registered for a course have the right to receive instruction/supervision for the duration of the time period specified for the particular course instance to which they were accepted. After that, the right to receive instruction/supervision expires.

The teaching is conducted in English.

### **Prerequisites**

A bachelor's degree (i.e., the equivalent of 180 ECTS credits at an accredited university) with at least 90 credits in global studies or social science including independent work, i.e., a thesis or the equivalent. English proficiency is required.

### **Examination and grades**

The course is graded Fail (U) or Pass (G).

The examination is based on the intended learning outcomes.

The course is examined through a written group assignment and an oral presentation at a seminar. The written group assignment and the seminar are only graded with U/G (Fail/Pass).

The examination must allow for students to be assessed on an individual basis. Further information concerning assessment of specific intended learning outcomes and grading criteria is provided at the beginning of the course.

To receive the final grade of Pass on the course, all elements of the course must have been passed.

Students are guaranteed a minimum of three attempts to pass an examination, including the regular attempt.

If a student has failed the same examination three times, the student can request that the next attempt be graded by a new examiner. The decision to accept or reject such a request is made by the associate dean of education. A student may not make a second attempt at any examination already passed in order to receive a higher grade.

In case a course is terminated or significantly altered, examination according to the earlier syllabus shall be offered on at least two occasions in the course of one year after the termination/alteration.
