Intended Learning Outcomes (ILO)

The purpose of the course is to provide students with a theoretical understanding of leadership in different contexts. The course is designed to develop the students' own capability and resources for leadership and a mix of theoretical and practical features in the course will enhance the students' ability to reflect upon different situations leaders encounter in their daily work.

On completion of the course the students will be able to:

Knowledge and understanding

- 1. identify, compare and evaluate the theoretical and practical leadership development
- 2. give examples of and critically assess the complexity of the leadership phenomenon

Skills and abilities

- 3. compare and contrast different leadership theories and critically evaluate them and relate them to practical situations
- 4. predict and draw conclusions about his/her future leadership style
- 5. practice own leadership team skills in cross-national teams and argue how they affect the team work

Judgement and approach

- 6. demonstrate a critical standpoint in regards to leadership in theory and practice.
- 7. outline and critically evaluate the challenge of the emerging concept of global leadership

Contents

The focus of the course is on the role and function of leadership in different settings. The course covers what leaders really do and why people follow them. Key concepts from leadership theories as well as emerging issues within leadership are critically discussed and evaluated during the course.

Type of instruction

Lectures, seminars and discussions.

The teaching is conducted in English.

Course evaluation

On the completion of the course the course evaluators and course examiner discuss the course evaluation and possible improvements. A summary report is created and archived. The reports are followed up by program directors and discussed in program groups and with relevant others (depending on issue e.g. Associate Dean of Education, Associate Dean of faculty, Director of PhD Candidates, Dean and Director of Studies). The next time the course runs, students should be informed of any measures taken to improve the course based on the previous course evaluation.

Other information

Academic integrity
